

## Notification of Sources of Distributions Pursuant to Section 19(a) of the Investment Company Act of 1940

### Quarterly Distribution for Sprott Focus Trust, Inc.

A quarterly distribution in the amount listed in the table below is to be paid on the Common Stock of Sprott Focus Trust, Inc. (the "Fund" or "FUND").
