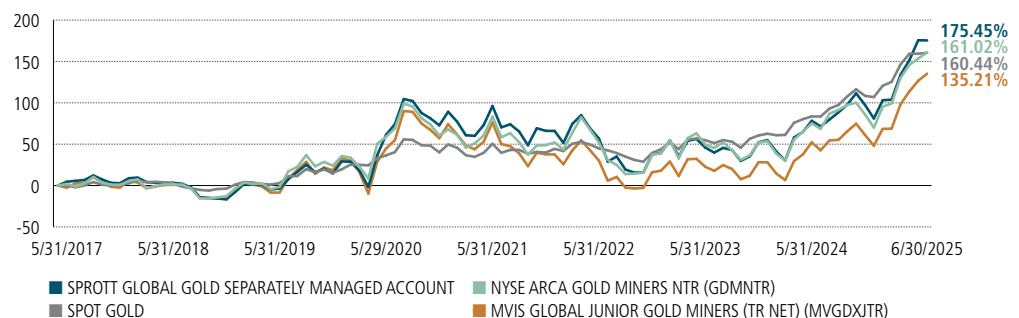

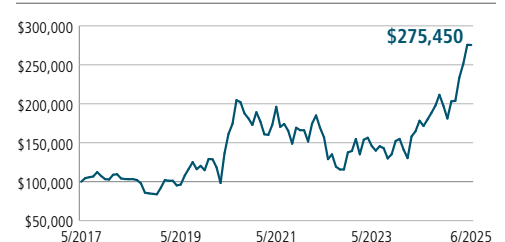
EQUITIES GEOGRAPHIC ALLOCATION
